Black and white or color photographic reproductions for one-time, one-use, non-exclusive, single language, publication rights. **The HBM will supply a 600 dpi (or best quality possible) digital file for use as part of the agreement.** The HBM currently does not offer hardcopy reproductions.

All requests for reuse or change in use must be applied for in writing to the HBM.

Non-Profit Eligibility: We are pleased to support non-profit organizations by charging them with reduced rates. These rates are only applicable to those organizations that are able to prove legal not-for-profit status by providing documentation such as a tax-ID number or letters of identification.

HBM Members: We are pleased to offer our HBM Members free access to digital files of photographs from our collections & archives free of charge as a benefit for their membership. Photos are only to be used for personal & private display/usage.
