## PHOTOGRAPHIC COPYRIGHT & REPRODUCTION FORM

Reproductions of materials from the collections of the Hermosa Beach Historical Society (HBHS) are provided under agreement for purposes as indicated in writing by the user and agreed upon by the HBHS. Conditions governing their use are specified by an agreement generated by the HBHS and to be signed both by the user and a representative of the museum. The HBHS reserves the right to require special fees for some forms of commercial uses. The prices listed herein are subject to change.

Black and white or color photographic reproductions for one-time, one-use, non-exclusive, single language, publication rights. **The HBHS will supply a 600 dpi (or best quality possible) digital file for use as part of the agreement.** The HBHS currently does not offer hardcopy reproductions.

**All requests for reuse or change in use must be applied for in writing to the HBHS.**

**Non-Profit Eligibility:** We are pleased to support non-profit organizations by charging them with reduced rates. These rates are only applicable to those organizations that are able to prove legal not-for-profit status by providing documentation such as a tax-ID number or letters of identification.

**HBHS Members:** We are pleased to offer our HBHS Members free access to digital files of photographs from our collections & archives free of charge as a benefit for their membership. Photos are only to be used for personal & private display/usage.

**This document applies to black and white or color photographic reproductions for one-time, one-use, non-exclusive, single language publication rights.**

# USER AGREEMENT:

I, \_\_\_\_\_, on behalf of \_\_\_\_\_ agree to the following terms and conditions:

**1. To use the photographic file only once and only for the purpose listed in the letter agreement's "Statement of Intended Use."** Use on an end paper or dust jacket or as any other advertisement constitutes separate use and must be applied for in writing. Additionally, any subsequent editions and/or different languages, etc. constitutes reuse and must be applied for in writing. There is a reuse fee.

**2. To credit properly:**

- The following is the basic credit line: *Hermosa Beach Historical Society & Museum Collections & Archives.*
- When provided, donor credit line must also be included in the credit line. We ask that you follow these guidelines:
- For published materials, the credit line should appear on the same or facing page as the illustration. Each individual image used must be credited separately.
- For films, filmstrips, and video presentations, include the credit within the "Sources for Illustrations" or "Credits" section of the production.
- For Web use, credit should appear either adjacent to the image or in a "Sources of Illustrations" section.

**3. To give the HBHS one complimentary copy of any published work**, including a digital file copy in which the photographic copy appears.

**4. To indicate in the accompanying caption or label any and all changes or alterations that have been made to the original digital file copy**, including cropping, tinting, or detailing.

**5. To not permit others to reproduce the photographic copy or any facsimile of it.**

6. In authorizing the reproduction of works within its collections, the Hermosa Beach Historical Society does not surrender its own right to publish or to grant permission to others to do so.

7. Any exceptions or modifications to the above conditions will appear on, and be considered part of, the museum's letter agreement.
